







Individuals applying for a qualification assessment under the National Quality Framework (NQF) must demonstrate proficiency in the English language.

The evidence required will depend on whether you are applying for an assessment against the guidelines for Early Childhood Teacher (ECT), Diploma level educator, Certificate III level educator or a qualified educator working with school aged children (OSHC):
